
Dear Mr. Traywick:

This is in reply to your letter of January 27, relative to dental work recommended for Mr. Lan.

As you know the dental coverage provided under the participants' health and accident policy is extremely limited. I have no doubt that the original bill incurred by Mr. Lan for \$12.00 and the subsequent bill for the removal of his tooth will be paid. The further treatment recommended by Dr. Nedelman will not be covered however. Only emergency treatment for the alleviation of excessive pain is covered under our policy.

We realize the situation Mr. Lan now finds himself in, however, under the circumstances we cannot advise you to have it done in the hope that the insurance will take care of it. It occurs to us that the University may have a dental school at which Mr. Lan could obtain treatment at a very reduced rate. This is merely a thought and is passed on for whatever it may be worth.
