CLASSIFICATION CRITERIA

THE FOLLOWING BIBLIOGRAPHY OF THE REPORTS AND DOCUMENTS OF THE MICHIGAN STATE UNIVERSITY ADVISORY GROUP IN VIETNAM INCLUDES EVERYTHING RELEASED BEFORE THE CLOSING DATE OF THE MSUG IN VIETNAM IN JUNE 1962.

TO CLASSIFY THE REPORTS AND DOCUMENTS THE FOLLOWING ORDER CRITERIA HAVE BEEN ADOPTED:

1. THE DOCUMENTS AND REPORTS ARE DIVIDED INTO THREE (3) MAIN CATEGORIES:
 - A. REPORTS AND DOCUMENTS IN THE FIELD OF PUBLIC ADMINISTRATION
 - B. REPORTS AND DOCUMENTS IN THE FIELD OF POLICE ADMINISTRATION
 - C. BIBLIOGRAPHICAL INFORMATION
2. EXCEPT FOR THE BIBLIOGRAPHICAL INFORMATION, EACH OF THE PREVIOUS CATEGORIES IS SUDDIVIDED INTO THREE (3) TYPES OF DOCUMENTS AND REPORTS:
 - A. REPORTS AND DOCUMENTS RELATED TO VIETNAM
 - B. SPECIAL WORK PLANS OR INTERNAL ADMINISTRATION REPORTS
 - C. TEACHING AND TRAINING MATERIAL
3. FOR THE REPORTS AND DOCUMENTS IN THE FIELD OF PUBLIC ADMINISTRATION RELATED TO VIETNAM, A SUBJECT MATTER CLASSIFICATION IS USED TO SORT OUT THE REPORTS AND DOCUMENTS; THEN UNDER EACH SUBJECT-MATTER HEADING THE DOCUMENTS AND REPORTS ARE FILED ACCORDING TO AUTHOR, ALTHOUGH IN SOME CASES NO SPECIFIC AUTHOR IS MENTIONED.

THE ORDERING CRITERIA ARE NOT ABSOLUTE SINCE THEIR PURPOSE IS TO PROVIDE A LOGICAL CLASSIFICATION OF REPORTS AND DOCUMENTS WHICH, BY THEIR VERY OVERLAPPING NATURE AND THEIR GREAT DIVERSITY, DO NOT LEND THEMSELVES EASILY TO ANY STRINGENT CLASSIFICATION.

THE AUTHOR, TITLE AND DATE OF RELEASE ARE GIVEN FOR EACH ARTICLE. UNLESS OTHERWISE SPECIFIED, THE PLACE OF ISSUE OF THE MSUG REPORTS IS SAIGON, VIETNAM. MOST REPORTS ARE MIMEOGRAPHED, BUT FOR THOSE PRINTED A (P) IS USED. A (V) OR (F) IS USED TO INDICATE WHETHER THE REPORT OR DOCUMENT EXISTS ALSO OR ONLY IN A VIETNAMESE OR FRENCH VERSION. THE NUMBER OF PAGES CONTAINED IN EACH REPORT IS ALSO GIVEN. THE TITLES MARKED WITH AN ASTERISK ARE THOSE IN PREPARATION AT THE TIME THIS BIBLIOGRAPHY WAS PREPARED.
