Dear Mr. Katzenburg:

On our I.C.A.-college contract with the Government of Viet Nam we have with us at Michigan State a Mr. Bui Nghi who has asked me to write you for certain information. Mr. Nghi is Director of Radio-Dalat and has been with his government for eight or nine years. In addition to his work in the U.S. in propaganda and public information techniques he is concerning himself with problems of public administration. He has become aware of the training program that the State Department conducts for its personnel specializing in certain areas. Is it possible for him to find out anything about that program and its content? There is a possibility that he may be in Washington this coming summer for four to six weeks. Would it be possible for him to spend some time observing that program? Or do considerations of security preclude this kind of activity?

Mr. Nghi is one of our more earnest and capable participants. I am particularly anxious to accommodate him in whatever way we possibly can while he is in the U.S. Needless to say, I would greatly appreciate whatever consideration you will give to this query. Thank you very much.

Dear Mr. Partle:

Mr. Bui Nghi is a participant on our I.C.A.-college contract with the Government of Viet Nam. He is currently in the United States while on leave from his position as Director of Radio-Dalat. The purpose of his stay in the United States is to develop his background in the area of communications, propaganda techniques, public information, etc. Here at Michigan State we have been able to offer him good facilities in the techniques of radio and TV programming and broadcasting as well as substantive work in international relations and public administration. However, we are limited in the ability to offer him what he really should have close contact with: that is, the actual organization and diffusion of propaganda.

Mr. Nghi arrived here in November and will be in the U.S. until August. Our current expectation is that he will remain with us at Michigan State until June taking course work, a certain amount of laboratory work in radio and TV, and spending some time with Governor Williams' press secretary at the Michigan State capitol. We feel that to really round out his work here the ideal solution would be to intern him with an organization such as yours for about a month during the summer. Is such a relationship possible? Do you have any sort of program for this kind of activity already established? If not with V.O.A. could you suggest someone at U.S.I.S. we might write relative to the same matter?

Needless to say, I would greatly appreciate any consideration you might give to this matter. Mr. Nghi is probably the most capable and earnest of the group we have from Viet Nam; I am particularly anxious to satisfy his needs here. Let me know if there is any further information you might want for further consideration.

Please forgive my delay in replying to your letter of March 6, but attempting to obtain answers to the questions you raised has taken a little time.

We were glad to learn of Mr. Nghi's interest in special area training but regret that only official Americans can be admitted to the programs which the Department conducts for its own personnel. The reason is security, as you supposed. No training program for foreign nations is now contemplated, except possibly for diplomatic personnel sponsored by their own governments. Even in that case, we seem to be limited by the availability of money, space, and personnel.

However, if Mr. Nghi should care to drop in on me when he visits Washington this summer, I would be most happy to receive him.

Subject: Request for extensions for Mrs Tan Thi Thanh and Mr. Buu Nghi.

1. Following the procedure set forth in Dorsey's memo to Sheinbaum of April 20 I am enclosing the two documents called for: the letter from Ed Weidner to Mr. Phan Van Tao, Assistant Director, Director Generale du Plan, requesting Mrs. Thanh's extension; and the letter to Mr. Tao from Mrs. Thanh herself. Sorry these took so long to obtain; we were awaiting Salter's approval which finally came yesterday.
2. Buu Nghi's work has been of such exceptional quality that it has been felt that an extension for him is certainly warranted. I'm enclosing a copy of Weidner's request to Salter which states the case:

I am requesting an extension of training in the US for Mr. Buu Nghi until June 1957. Mr. Nghi's work thus far at Michigan State has been of an exceptional quality. His primary area of interest is in mass communications media; he was director of Radio Dalat in Vietnam. The radio and TV institute on campus have served as an excellent laboratory for him. In addition, however, Mr. Nghi has developed a rather profound interest in current problems of international relations and international organization. The faculty under whom he has worked in these fields have been overwhelmingly impressed with his grasp and his ability. Certainly his approach and attitude warrant the opportunity for a more complete development; more important, the opportunity of completely integrating in this one person both the substantive matter and the techniques of public information is one that should not be foregone. The additional time will enable him to undertake new training in press relations and propaganda techniques as well as to continue to deepen his background in the substantive fields. I am convinced that with extended training he will return to Vietnam not only as a definite asset to his government, but also as a very positive indicator of the value of this kind of program.

Salter approves providing we can get clearance from the proper Vietnam Govt channel

I would appreciate a cabled response in both cases, Thanh's and Nghi's.

Dear Mr. Nghi:

I am enclosing a copy of the application blank that you must fill out for graduate study. It is assured that you can work at least for a Bachelors Degree and it is almost definite that you will be able to work toward a Masters Degree. You will have to obtain whatever records of your college experience in Vietnam that is possible. I urge you to do this at once. Further I have received the following memo from our Saigon Office: "The Commission on Foreign Study of the Vietnamese Government has been informed of the extension of the training of Mr. Nghi and seem inclined to accept the proposal. However, they have requested that Mr. Nghi submit his own request for an extension of his leave of absence from official duties. This request may be addressed to the Commission and then sent to us and we will see that it gets into the proper channels." I urge you to immediately send the request asked for and to give me a copy of that request. Also fill out the application over the week end.


