Dear Mr. Coppinger:

If it is possible I would like to arrange for Messrs. Huynh Van Dong and Nguyen Van Son to visit the Japanese Personnel Authority and the International Training Center, in Tokyo, while enroute to Saigon. These two gentlemen have attended courses at the American University in Personnel Administrational Organization, and Methods. In addition, they have spent considerable time in both private and governmental agencies observing Personnel and Organizational Methods Operations.

Mr. Son, who is with the Vietnamese equivalent of the United States Civil Service Commission, will be responsible upon his return for the presentation of materials on personnel administration. Dear Miss Cunningham:

Thank you for your letter of December 29, 1958, regarding the proposed visit to Japan of Messrs. Huynh Van Dong and Nguyen Van Son from January 21 to 28, 1959.

While we are always pleased to assist participants in making arrangement to visit Japanese Government offices such request must come through the International Cooperation Administration office in Washington, D.C., or the United States Operations Mission to Vietnam. In this way we know that the participant's Government approved the stop-over and that the visit is not made merely for the convenience of the participant. On approved visits funds sufficient to cover his per diem allowance and travel costs in Japan are then transferred in the Program Implementation Order to this office.

Since time does not permit us to put this program back in channel in this instance, we will make arrangements for Messrs. Huynh Van Dong and Nguyen Van Son to visit the Japanese Personnel Authority on an informal basis.

I know I can count on your cooperation in clearing future Japan stop-overs with the International Cooperation Administration in Washington.

Dear Mr. Dong:

We have been advised today by the Viet Nam Project at Michigan State University that the class of your travel over the Pacific returning to Viet Nam should be reduced from First Class to Tourist Class travel.

We have accordingly passed this information to Pan American and have asked them to contact you in California arranging for the reissuance of your tickets to accomplish the requested Tourist Class transportation, and also to revise your reservations accordingly. We have further advised them that the saving in fare resulting from this change of class in transportation should be forwarded by cablegram to M.S.U.G. in Saigon.

In view of this change in plans, we are returning to you with this letter exchange orders forms 0269-849891 & 2 and exchange order form 0269-805345 which have been unused. Also enclose is American Airlines excess baggage voucher form 0266-218990 which has been unused. Also enclosed are your old ticket stubs in the event that they are called for on the west coast.

Please handle the adjustment of your travel directly with Pan American.

SUBJECT: Downgrading of tickets for Son & Dong. (#83)

Since Mr. Son and Mr. Dong were already on the west coast when they received word concerning the change in tickets they took their tickets to Pan American. At the time no one explained to them that the three exchange orders they held would in no way cover the difference in baggage allowances from first class to tourist. This situation has been resolved in the following manner:

The exchange orders, plus approximately \$60. of the residual value of their first class tickets were used to cover shipment at the cheapest rate for Commodity Air Freight. This also necessitated using the maximum weight allowance for shipment which was 77#. You will receive notification from Pan American in San Francisco regarding the computation of these costs, but since it was practically impossible to do anything else they would be satisfactory. This seems like the best solution all around.
