Dear Miss Cunningham:

Replying to your letter of August 8, I would advise that I do not expect to be in Toronto at my desk until September 11, after the first of September. Most finance officials of the provinces and of Canada will be in Fredericton, New Brunswick, attending a conference from September 3 to 9, both inclusive, and I would not expect to reach Toronto until some time on September 10.

General government accounting procedures, in so far as the Province of Ontario is concerned, may be studied under the direction of W.C. Browning, Comptroller of Accounts in the Treasury Department, and I am sure that he would be glad to meet and introduce to others Mr. Phan Dinh Ngoc on September 11. He may be available on September 10 but so far as the Deputy Treasurer, the Comptroller of Finances and myself, the Comptroller of Revenue, we will all be in Fredericton and will not be available before September 11.

As regards your inquiry concerning accounting procedures that apply with the federal government at Ottawa, I would suggest that you should consult Mr. H.R. Balls, Director, Financial Administration and Accounting Policy Division, Department of Finance, 217 Confederation Building, Ottawa, Ontario.

I would be very much appreciative of some information or report on Mr. Phan Dinh Ngoc's Accounting course at George Washington University. He has failed completely the courses in Auditing and Controllershship. In speaking with the instructor yesterday he indicated that perhaps it was the combination of concentrative work, which is an essential feature of the summer session, his English difficulty, and their general inability to place him in the proper level course.

In his conversation at the Department of Accounting he indicated a desire to follow a course in Federal Governmental Accounting. This seems ridiculous and ironic to me since he has already had such a course at G.W.U. and courses strictly relative to Federal Accounting are not available on this campus.

In the face of this record I am in rather dilemma as to how to proceed for the fall quarter, but I assume that it would not hurt him to make another attempt at basic course work here.
