SUBJECT: No. 24 - Mr. Pham Quan Pham

Mr. Pham has recently informed me that the Governor of the National Bank of Vietnam has some serious reservations about his working for a Master's degree and possibly staying on in the States for an additional three months. The Governor has suggested as a possible alternative that Mr. Pham spend three to six months in academic work and the remaining months in observation and on-the-job training.

Mr. Pham, at the time of his departure today, is still somewhat confused as to what he will do. I am certain that he will arrive in East Lansing in a state of similar confusion. I have suggested to Mr. Pham that he consult with you prior to his registration for courses this quarter. I would like to repeat that in my estimation Mr. Pham is one of the most talented people we have ever sent on a participant grant. He is mature, intelligent and a very sensitive person. He will respond, I am certain, to any positive suggestions you can make when discussing his problem with him.
