Dear Mr. Calhoun:

We have recently been discussing with Mr. Pham Quang Pham his program during the year he will be in the United States as a participant under the sponsorship fo the Vietnam Project. He has indicated that the Governor of the National Bank of Vietnam wishes him to spend approximately nine months of this period in training at your bank.

Mr. Pham is the Assistant of Mr. Le Phat Dat, Foreign Department, Banque Nationale du Viet Nam, Saigon, and met you while you were in Saigon. Since he is presently enrolled at the University I would like to suggest that Mr. Pham start training in Investment Banking at your bank either around December 16th or 17th or else after the first of the year.

Any suggestions you might have regarding suitable places where Mr. Pham might seek accommodations for this period would certainly be appreciated.

As a matter of fact at the present time we have in training a fellow countrymen of Mr. Pham's, Mr. Vilte Gy.

Dear Mr. Governor:

We have recently received a request from our Vietnam Project Coordinator's office at Michigan State University concerning the participant training of Mr. Pham-Quang-Pham, a staff member within the Foreign Banking Department of the National Bank of Vietnam. Mr. Pham, who is now studying economics at Michigan State University under our participant program, is beginning to plan the portion of his training which will be non-academic. In making arrangements for this portion of Mr. Pham's study, we find that it becomes necessary to request some assistance from you.

We are informed that a letter directly from you to the First National City Bank of New York is needed. This letter should request the First National City Bank as a correspondent bank to arrange training for Mr. Pham. Your letter should be addressed to Mr. C. R. P. Rogers, Assistant Vice President, Overseas Division - Personnel.

A similar letter would also be useful to the International Monetary Fund and the National Bank for Reconstruction and Development. I am not at this time able to give you the exact dates that Mr. Pham will visit these organizations. However, a general request for training will, I believe, be sufficient. Would you please send me copies of the letters you write to each of these organizations so that I can inform our Coordinator in East Lansing.

I believe you would be pleased with Mr. Pham's work as a participant. During the period of English training, prior to departure, he demonstrated a sincere desire to learn and to broaden his professional competence. The National Bank of Vietnam has in Mr. Pham a very fine representative in the United States.

I will keep you informed of his progress while he is away, and I hope that you will feel free to make suggestions or comments on the training he is receiving.

Please accept, Mr. Governor, the assurances of my high esteem.


Re: Mr. PHAM QUANG PHAM

He pointed out certain questions which he felt should be answered and which we would like to discuss with him before any final arrangement is made. I would like to know when Mr. Pham will be through his curriculum at Michigan State University. Also, how much longer his visa would allow him to stay in this country and what specific plans Mr. Pham might have.

Once we have this information we will then be able to determine what sort of training will be best for Mr. Pham. We will look forward to hearing from you.

Dear Mr. Rodgers:

With regard to Mr. Pham's work here at the University - the term will be completed December 12th.

At present I am hoping that Mr. Pham may be able to spend a week or two at the offices of the International Monetary Fund and the Bank for Reconstruction and Development in Washington, D. C. However, if it is not convenient for him to visit these organizations at this time I shall let you know and perhaps he could start immediately with your bank.

Mr. Pham's visa is good until September 1959 and will only require extention of the entry permit following the first six months period of his stay.

He, therefore, will be at the Bank from January 5th onward if this is convenient. The specialization that we have been requested to seek for Mr. Pham is in Investment Banking. In your talk with Governor Hanh and Mr. Pham, after his arrival, perhaps a more ideal training program can be set up than through the vague idea of Investment Banking.

Thank you for your assistance.


Dear Miss Cunningham:
