Dear Miss Cunningham:

We shall be glad to have Miss Kim Sa as an NDC student for this summer session. I presume that we will get some official paper on her such as I received from Mr. Harper of the Office of Education on Miss Nguyet. It will be necessary to have an address for her so that a permit to register may be directed to her. I should like to point out that there is a conflict in the hours of 165h and 206. 165e at 7:45 A.M. will serve as well. In 165h there is an attempt to get people who are interested in older students, in 165e those interested in young ones. But this is not always possible and our library school students often prefer 165e. The film reviewing may suit their own tastes and needs in either class. Also 165e is to be taught by Dr. Frederick White, Director of our A-V Bureau.

In the case of Miss Nguyet, I sent a letter to Mr. C. B. Horswill, Bursar, University of Wisconsin, 831 State Street, telling him who would be responsible for her fees. I think it would be well for you to write to him, and will you please send me a carbon of the letter? Does this mean that you will also pay for Miss Kim Sa's living and incidental expenses? And how is that cared for--does she receive the money and thus assume responsibility for payments, or do you pay that directly to the place where she is to stay?

I suggested to Miss Hunt that Miss Nguyet try to stay in Elizabeth Waters Hall, a University dormitory where many of our students stay in summers (it is an undergraduate hall in regular sessions) and I think that this also would be my suggestion for Miss Kim Sa. I am asking the Summer Sessions office to send you a catalog and full information on housing, etc., so that you may learn what is available. Perhaps Miss Kim Sa, there in Cleveland, may use the materials that I have sent for Miss Nguyet.

Dear Miss Schenk:

No doubt you have been engulfed in the same seasonal pressures so that you had not missed my reply to your letter of June 2, but I am sorry it has been so long delayed. You need have no concern over not sending me a carbon of your letter to Miss Cunningham in regard to Miss Kim-Sa; after all mine is a role soon to end in her case and I pointed you in the direction of Michigan where the responsibility lies until her departure from the country. However I have been temporarily drawn into advising on Miss Kim-Sa's program since there is less familiarity with details of library education in the Project office in East Lansing.

Because of the conflict in class hours and also because Spanish was found to be a requisite course for Miss Kim-Sa's bachelor's degree in the Phillipines, we have made the following recommendation;

Spanish (4)  
Introduction to Library Materials (2)  
College and University Libraries (3)

We think she can handle the 9 hours but if this proves too heavy it is your course, unfortunately, in College and University Libraries which is the elective in her case rather than the vital area of Library Materials in which she has had no work at all due to her tutoring in English here.

Both Miss Nguyet and Miss Kim-Sa have been instructed to notify you well in advance of their arrival since both have left this campus prior to commencement for stopovers elsewhere - Miss Kim-Sa in Washington, Miss Nguyet in Chicago.

My flying trip to Washington will unfortunately not coincide with yours as I am attending the pre-conference on young adult books and Monday only of A.L.A. I hope our paths may cross at some other time as I remember with pleasure our last brief meeting.
