I spoke to Marvin Murphy, concerning your memo of February 17th. He agrees that it would be useful to give Mr. Suu a good background in performance budgeting. He feels also that this would be consistent with Mr. Thai's plans.

In addition Marv made the point that GVN is considering the possibility of establishing performance budgeting in the Department of Health. While it is not certain that they will, if they do, it is possible that Mr. Suu might have responsibility in this program.

The budget participants in Washington, D.C., are all taking budgeting and accounting courses at American University. Following their course work they will engage in a workshop conducted by ICA Washington, (similar to the one that Nguyen Thuan attended, but shorter) after which they are tentively scheduled for work at Michigan State University. These men are important to the budget program and all seemed impressive during their period of English Training and Orientation. I have asked them to keep you informed of their activities during their period in Washington, D.C. (please see attached).
