Mr. Huynh Xuan Tho is leaving for Washington today. There he will attend the American Language Center for three or four weeks.

This morning we worked out a tentative itinerary to cover most of his stay in the United States. However, if he receives permission to return home via the United Kingdom, there would be some changes dictated by the fact that he would be leaving from the east coast rather than the west coast. If the possibility of his returning via Europe has not already been explored, I would appreciate your doing so and letting us know as soon as possible what the chances of permission being granted for this are.

Wes Fishel is accompanying Mr. Tho to Washington and will also meet with our political science graduate students who are currently attending the American Political Science Association annual conference.

Mr. Tho has already met with Dr. Cline and also briefly with Dr. Hildreth. They have both offered to cooperate fully and Dr. Hildreth has indicated that he will inform all of his staff of Mr. Tho's mission and request their cooperation.

Elsie gave me your letter to her of September 11, 1959 concerning Mr. Tho's itinerary. Here is the situation: One of the first things that Mr. Tho said to me when I met him at the airport was that he wanted to stay in East Lansing for six weeks brushing up on his English and studying the elements of American taxation. He felt that he would be in a much better position to benefit from his experience than if he went out after a brief stay in East Lansing. I might add that he was quite adamant in this position, and I felt that I could not refuse a request of this nature from a person at his level. He spent approximately one week exhausting the English tapes we have in our language library here and devoted a good part of his time to reading Grove and Poole on taxation. He also spent a good part of one morning with Professor Cline going over his prospective itinerary.

At the conclusion of this first week it became clear that we could not satisfy his language needs here. The logical thing to do in view of his insistence on this matter was to send him to American University.

I am sure that he will use his time to good advantage both in the language and tax spheres. Besides, at the tail-end of his stay in Washington, we hope that we can arrange visits to the Bureau of Internal Revenue and the International Monetary Fund which will eliminate the need to return to Washington at a future date.

I was very anxious to get him started, but I hope that you will appreciate the importance of the initial adjustment which must be made in the United States. I felt that the investment of additional preparatory time was well worthwhile in view of the very great contribution which Mr. Tho will make upon his return. We have gone to unusual lengths here to accommodate Mr. Tho, and I did not want to jeopardize our relationship by requiring him to do something against his will. I am attaching a copy of Mr. Tho's itinerary.

SUBJECT: Mr. Huynh Xuan Tho's Puerto Rico Trip (#299)

In discussing the program for Mr. Huynh Xuan Tho in Puerto Rico with Mr. Simon Weinger of ICA yesterday, he indicated that we had chosen what was possibly the worst time of the year from the standpoint of holidays. According to him, the whole week preceding Christmas and the week after the first of January are big holiday periods in which you could not expect to accomplish any significant amount of work. With this in mind, I have now tentatively suggested that Mr. Tho's Puerto Rico trip begin on January 23rd.

I had originally thought that we might send him to Puerto Rico directly from Washington, but concern for the possibility that he might have to cope with English spoken with a Spanish accent when he is just achieving a minimum degree of fluency in English, plus the fact that it might be well if he had the opportunity to learn more of the American tax setup before he went to Puerto Rico, made me shift this visit to a later date.

Mr. Le Quang Huynh arrived very exhausted after a tiresome trip from San Francisco to Chicago, but now seems to be completely revived. Jim Hendry has signed him up for Economics 406 and 320, and Insurance, Law and Real Estate 360. He indicates that one of his major responsibilities on his return to Vietnam will be the reforms in property tax. I feel confident that he will be able to follow these three courses with no difficulty. His English is excellent and better than that of most participants newly arrived in this country.

Huynh Xuân Tho's Program

I must admit that my mild complaining about Mr. Tho's English training in Washington was impetuous and that more English training is probably advisable. At any rate, I must admit that you know more about this than I do.

Referring to a Memorandum of September 9, 1959 from Elsie Cunningham to Howard Waltman, the question of Mr. Tho's return via Europe has been explored. I am very anxious for him to travel through Europe and Mr. Tho would also like to do this, but he was reluctant to raise the issue before leaving Viet-Nam. Ralph Smuckler is of the opinion that we could help to obtain permission for the trip at this end. I am going to contact Mr. Tho to find out if he would like us to intercede.

Regarding Mr. Tho's itinerary, I have the following reactions: (1) After he leaves Washington, he is going to be on the road for successive trips to New York, Albany, Boston, and Ottawa. This may prove to be too tiring, so it may be best to bring him back to East Lansing for a rest before he goes to Ottawa. (2) Is one week in Chicago necessary? (3) If Mr. Tho travels home via the Pacific, I suggest the possibility of a stop in Oregon to view tax administration there as well as to see Dick Lindholm. (4) Please consider four or five-day stopovers in Japan and Taiwan.

In personal letters from Mr. Tho, he expresses enthusiasm for his welcome at MSU, for which you and Elsie are to be congratulated.
