Referring to your two memoranda of October 2, 1959 concerning the above two participants:

- (1) I believe that it is a mistake to schedule Mr. Tho's visit to Puerto Rico immediately, but it appears that it is too late to do anything about it. Mr. Weinger had a good idea in avoiding the Christmas and New Years holidays, but scheduled a worse time -- that is, before Mr. Tho is ready for Puerto Rico.
- (2) Mr. Huynh's future responsibilities with respect to the property tax is news to me. Apparently, this is an assignment that he has been given by Mr. Tho recently. In view of this, and because Mr. Tho is insistent that educational programs should be adapted to the particular needs of participants, I am sympathetic with the idea that Mr. Huynh be given the Spring Quarter off for field work in the property tax. However, I do not see any reason why he should leave Michigan. He could live on the campus and do field work in Lansing, East Lansing, Okemos, and Detroit, learning all the principles and practices involved in property tax assessment and collection. As you point out, we have all the contacts in Michigan for productive field work which we would not have in other states.
