WE HAVE RECEIVED MR. TRAN NGOC PHAT'S PASSPORT WITH THE REQUEST THAT THIS BE RENEWED UNTIL JULY 1, 1962.

WE HAVE FORWARDED HIS REQUEST TO PROFESSOR MUSOLF OF MSU GROUP IN SAIGON TO PROCESS HIS EXTENSION AS A PARTICIPANT IN THIS COUNTRY UNDER HIS COMMITMENT TO THE NIA. PHAT HAS INDICATED HE SHOULD LIKE TO RECEIVE HIS RENEWED PASSPORT BEFORE DECEMBER SO THAT HE CAN APPLY FOR THE EXTENSION OF HIS AMERICAN VISA.


Dear Dr. Austin,

Thank you for your recent letter and also the per diem check for the second period of this month. I appreciated your having agreed to loan certain material helpful for a paper I am writing as requested.

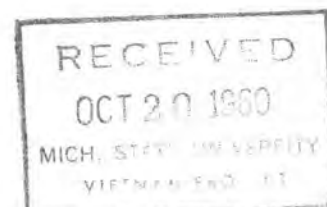

AS OF NOVEMBER, 1960, PER DIEM WILL BE PAID ONE FULL MONTH IN ADVANCE. ENCLOSED HERewith IS YOUR CHECK FOR \$240 COVERING THE PERIOD NOVEMBER 1 THROUGH NOVEMBER 30, 1960.

THE ADDITIONAL \$4 PER DAY, PAID WHILE IN TRAVEL STATUS, WILL BE PAID TO YOU SEPARATELY AND NOT COMBINED WITH THE REGULAR \$8 PER DAY SUBSISTENCE CHECKS. ALSO, PLEASE BE ADVISED THAT THE EXTRA PER DIEM, LIMOUSINE AND TAXI FARES IN CONNECTION WITH OFF-CAMPUS TRAVEL CANNOT BE PAID UNTIL THE CANCELED RECEIPTS AND/OR TICKET STUBS ARE RECEIVED IN THIS OFFICE. IN OTHER WORDS, THE ADDITIONAL PER DIEM AND TRANSPORTATION EXPENSES CANNOT BE PAID UNTIL AFTER SUCH A TRIP IS MADE. IF, HOWEVER, TRAVEL ARRANGEMENTS ARE MADE THROUGH THIS OFFICE, THE TRAIN OR PLANE FARE WILL BE PAID BY THIS OFFICE IN ADVANCE OF YOUR TRIP, AND TICKETS WILL BE FORWARDED TO YOU AS HAS BEEN THE PAST PRACTICE.

THE \$120 BOOK ALLOWANCE WILL BE PAID \$60 AT A TIME ONLY AFTER WE RECEIVE FROM YOU RECEIPTS TOTALING THAT AMOUNT. BOOK ALLOWANCES CANNOT BE PAID IN ADVANCE.

ONE MORE ITEM IS THE MATTER OF REPORTING. ATTACHED IS A SAMPLE REPORT WHICH WE WOULD LIKE FOR YOU TO FOLLOW AS CLOSELY AS POSSIBLE. WE REALIZE SOME OF THE PARTICIPANTS HAVE COMPLETED THEIR COURSE WORK, IN WHICH CASES A GENERAL REPORT IN PARAGRAPH FORM WILL BE IN ORDER. WE LOOK FORWARD TO RECEIVING SUCH A REPORT EVERY THREE MONTHS, THE FIRST ONE BEING DUE DECEMBER 31, 1960.

ANY FIELD TRIPS TAKEN SHOULD BE WRITTEN UP AS A SEPARATE REPORT AS SOON AFTER A TRIP IS TAKEN AS IS PRACTICABLE.

Dear Dr. Austin:

I have well received your two letters dated October 27 and 28, 1960, as well as the Quarterly Report form and the check for the November monthly allowance. I thank you also for having sent me the English copy of the Presidential arrête concerning my extension.

I particularly appreciated your arrangements in connection with my planned research trip to East Lansing during the later part of December, 1960. Please be kind enough to make air reservations to the effect that I shall be able to leave Cambridge on the 21st of December and to return from East Lansing on January 2, 1961.

I found your re-statement of and changes in administrative procedures quite helpful. Receipts of books purchases will be forwarded to your office for necessary financial adjustments. With respect to the Quarterly Report, there is only one point which ought to be brought to your attention: Insofar as I know, the course work requirement at Harvard is not measured in terms of credits but rather in terms of the number courses completed to satisfy the residence requirements and the grades for the courses cannot be obtained until the end of the semester, i.e. by the middle of February, 1961 for the current term. In other words, unless otherwise guided, the first report due December 31, 1960, will of necessity consist of the general progress in the courses I am currently taking.

I am sure you understand my anxiously expecting the arrival of the material on Viet-Nam which was requested three weeks or so ago. Please also be advised that, in addition to a renewed passport, I shall need a DSP-66 form from M.S.U. in order to get an extension for my visa.

For all the good news I have got through your last communication with me, I am much obliged to you.

Dear Dr. Austin:

It is always the case for me to stop sometime in the course of the academic flow and find myself in a rather embarrassing financial situation. I hope you will forgive me for bringing this problem to you with a spirit of urgency; but such is the case, unfortunately.

I am enclosing the receipts of the books I have purchased so far in the hope that you will be willing to get re-imbursement for that amount as exceeding the \$60 already advanced to me as early as it will be feasible.

I am also requesting you to give me in advance the \$4-differentials for my scheduled trip to East Lansing for the period from Dec. 21, 1960 to January 2, 1961. Having just received a quarterly rent bill from Harvard housing office, I realized, to my dismay, that without such a cash advance I will be financially unable to make that much longed for trip. In such an event, I will have to send the tickets back to Judy.

To let you know, if you would not mind, about the whole situation: I had to pay, recently, two dollars and thirty-five cents for "poll tax." Could I get re-imbursement for that? And would there be any statement on your part whereby I would not have to be disturbed in my studies by tax collectors? I know that Elsie could have done something about it, but I do not know how and what really in my present case. As you may realize, I need wholesome concentration and I appreciate anything you can do to help me in this direction. Actually, I am so involved with the work-load (papers and preparations for final exams in courses) of this term that I have had to decline, gradually, all my social activities -- including the ones, though very occasional, with the Vietnamese Students' Association, which I am going to drop for good.

Another matter was concerning the extension for my visa. So far I sent my passport to the Boston Immigration Office for renewal of visa and there was no complication. This time, following an instruction kindly extended to me from M.S.U.'s Foreign Students' Adviser Office, I have sent it to the Detroit Office and the latter has returned it to me asking for an explanation of my presence at Harvard. I have complied with their demand and sent a note explaining our program to them. I do not think that there will be any difficulty at all. This is just another minor inconvenience added to the above. Please forgive me for having to impose upon you with such details, but I felt the need to ask for your comprehension and support in all the related instances or similar ones in the future.

I would be grateful if you could act favorably on the requests contained in the present. My work is progressing regularly.

FIRST OF ALL, REGARDING YOUR BOOK ALLOWANCE, I SHALL BE HAPPY TO FORWARD TO YOU THE REMAINING \$60 OF YOUR YEARLY ALLOWANCE (PLEASE UNDERSTAND, HOWEVER, THAT, IF I DO SEND YOU THIS SECOND \$60, YOU WILL HAVE RECEIVED A TOTAL OF \$120 AND WILL NOT BE ENTITLED TO ANY MORE MONEY FOR BOOKS UNTIL SEPTEMBER OF 1961) AS SOON AS YOU PROVIDE ME WITH A STATEMENT SIGNED BY YOUR ACADEMIC ADVISOR OR MAIN PROFESSOR THAT THE BOOKS YOU HAVE PURCHASED ARE RELATED TO YOUR FIELD OF STUDY. FOR THIS PURPOSE, THE RECEIPTS YOU HAVE SUBMITTED ARE BEING RETURNED TO YOU HEREWITH.

SINCE YOU HAVE NOW RECEIVED YOUR SUBSISTENCE PER DIEM FOR THE MONTH OF DECEMBER, TOTALING \$248, WE CANNOT JUSTIFY PAYMENT OF YOUR TRAVEL PER DIEM IN ADVANCE OF YOUR TRIP. TRAVEL RECEIPTS MUST ACCOMPANY OUR REQUEST FOR THE EXTRA PER DIEM.

ENCLOSED IS A STATEMENT DESCRIBING YOUR STATUS AS A STUDENT; WE CANNOT REIMBURSE YOU FOR THE POLL TAX, BUT YOU MIGHT BE ABLE TO GET IT REFUNDED BY SHOWING THIS STATEMENT TO THE PROPER AUTHORITIES. THIS STATEMENT ALSO CAN BE USED IN THE FUTURE WHEN YOU ARE APPROACHED ABOUT PAYING TAXES.

WE LOOK FORWARD TO SEEING YOU LATER THIS MONTH. HAVE YOU MADE ARRANGEMENTS FOR A PLACE TO STAY WHILE YOU ARE IN EAST LANSING? IF NOT AND WE CAN BE OF HELP, DO NOT HESITATE TO LET US KNOW.

Dear Dr. Austin:

I would like to thank you for many of the nicely thoughtful things that you have done for me lately. Please kindly forgive me for not having been specific enough in my recent communications with you, during a rather concentrated period of research work for me here. But I am looking forward to having the privilege and pleasure to report more in detail to you about my work and plans, in the course of my next research trip to East Lansing.

As a good contributing resident of Cambridge, I was happy to have paid the poll tax anyway. But I appreciated your certifying statements which will help me to keep the whole (reduced) amount of per-diem for my own subsistence and some of the other necessary working expenditures not covered by my present scholarship.

The passport has been returned with the one-year extension of stay grant, as requested. I am glad to let you know this good news too.

With Christmas time in the offing, I cannot help to exhibit here my gratefulness to all who have so generously supported me in my studies even in the most difficult hours of adjustment. Studying for a higher degree in Political Science, as you are aware, requires the most both extensive and intensive involving in many disciplines and branches of life in many places. Without your sustained support and help as well as the ones from many other friendly and cooperative sources, my academic pursuit could not have progressed as relatively effectively as it did. In the coming year, I am looking forward to an even more effective and useful period of accomplishments.

In reply to your most recent letter, dated December, I would like to re-state, somewhat briefly awaiting a further opportunity to discuss things of the following nature with you soon, some explanations concerning my fields of study at Harvard. As you may know, the Government Department here is a subdivision of Harvard Graduate School of Arts and Sciences. The Government Department is entitled to govern the work and grant degrees in various fields (I should say, super-fields) of social sciences. For the degree of Ph. D., for example, it offers, among others, degrees in History, Economics or Political Science. In order to get a Ph. D. degree in Political Science, which is a degree in Arts and Sciences (as opposed to specialized degrees such as the Master of Public Administration or Ph. D. in Economics and Public Administration, etc., offered by more specialized Schools or degree-granting commissions), a candidate must submit-at the end of his first year of graduate study under the Department of Government-an application for candidacy for the degree of Ph. D. in political science (which I had done) stating the six fields of study he wishes to offer at the General Examinations (the equivalent of the Prelims. at M.S.U.), among which is a special field (meaning that on which he will be asked more in detail at the General Written and Oral Examinations). In preparation for these examinations, the courses do not officially be an integrated part; the candidate must prepare for these fields, in addition to the course work, by extra readings and research work on his own so as to be ready for these examinations. Among the six fields, there can be two "write-off" fields meaning that you may not present them at the Generals if you take two courses in each and satisfy the appropriate requirements for these two fields in the course work. The fact that I did ask to change my special field from Public Administration to Nationalism (an inter-disciplinary concentrated field in International Relations at Harvard, and a would-be originality of this University's curriculum) was much more a technical change in the original application for candidacy than a change in field of study in the sense of another University's context. I intend to present for this field two areas of concentration, which will be the former Indochina and perhaps India areas of concentration. In practice, governmental problems in general or in comparatively-applied forms will include public administration, among other fields of government and law. As a student in Arts and Law*, and as someone

interested in governmental aspects and developments of transitional societies such as Viet-Nam (in which every problem of law and government must be, by a finding in socio-historical research in the evolution of these societies, put in the general framework of emerging nationalisms for understanding as well as for an eventual comprehensive solution thereof), I firmly think as I thought and accordingly carried out my studies so far, that Nationalism as an impact-field of knowledge (and transfer of knowledge) of a national, supra-national and international nature most useful for a smooth and orderly process of generational integration in societies such as Viet-Nam. But the overall field of my degree is still Political Science as previously explained. As a Professor in Political Science at the National Institute of Administration, I shall be teaching Public Administration, Nationalism, American Constitutional Law, Political Thought, or any matter-subject I shall be called upon to teach and for which I had been trained and am going to be trained, with the advices and research sources from M.S.U. or Harvard or any other institutions of learning and foundations of research with which and whom I have and will have maintained a continuing flow of contacts in the backing; and, above all, with your support and help in getting recognition for my fields of study and teaching at the National Institute of Administration or any other higher institutions of Viet-Nam should the needs of the country (in conformity with the U.S. interests) so require,-- which support and help among many precious others I would most wholeheartedly and gratefully request and appreciate.

Finally, in connection with my forthcoming trip back to M.S.U. (my American cradle-University), and at the risk of abusing, once more, your express kindness, may I submit two specific requests. The first one concerns my housing problem overthere. I know from past experience, that it will be difficult for me to find a place of dwelling at a rate I can afford in that so conspicuously attractive city. Could you intervene so as to get for me a room in M.S.U.'s dormitory for a week or so? And also, I should greatly appreciate your letting me know at your earliest convenience if I shall be able to use a typewriter which could be made available to me in Viet-Nam Project's offices even during the nights and weekends? Such a providential help would save me from overloading my luggage with a portable typewriter.
