Dear Judge,

It was nice seeing you again in Saigon.
I hope you enjoyed the baseball game!

I was a bit disappointed for not having been able to bring Mr. Ky along with me to Washington D.C. - He told me he has many things to do at Ann Arbor for the moment. He is expecting your forthcoming visit to the U of Michigan.

Shortly after my arrival here yesterday, I saw Mr. Dang and Kim Sa at dinner. Mr. Dang is looking forward to having the company of Mr. Thong who will be arriving tonight; and Kim Sa is very anxious to get back to her studies (and Else) in D'anna.

For my part, I am also waiting to hear from Mr. Thong (since Mr. Dang has returned to me the same certificate of my success at the Generals at Harvard, which he had demanded for the decision on my plans as approved by Dean Austin and Dr. Hendry), as well as from Saigon

about the status of my plans for research and writing for my dissertation. — As you might have been already aware, these plans are still in an undecided stage: Either they will be approved, and I shall be leaving for Europe and Göt. Dau in October for a 7-month period of research, before coming back to the States to finish my dissertation; or, else, I shall have to work out, again, another set of plans and pick up another topic which will not require my visit to Göt. Dau. In the latter case, I shall have to submit an application for extension of stay until completion of my dissertation, which was, at one time, my original plan. — I have been asked by the Registrar of the Graduate School of Arts and Sciences at Harvard to let them know (on a form sent to me) if I expect to come back to the GSAS next Fall: Since my present plans are still undecided by both U.S. and U.N. sides, and since Dean Austin has mentioned to me the eventuality of the necessity to pick up another topic which will not involve my visit to Göt. Dau, I have

thought it appropriate to answer "Yes." In the one case, I shall be working at Harvard during July - August - September, and part of October. In the other, I shall register for thesis writing for the whole academic year 1961-62. Please bring these facts to the knowledge of Dean Austin and Dr. Hendry.

In the meanwhile, I plan to work at the library of Congress (Washington D.C.) and the Brattleboro library (New York City) mainly -- whenever possible, I shall also interview accessible people who may help me in furthering my research for my dissertation.

The Tran Q. THAN's have invited me for dinner at their house this evening, at which will also be present Mr. Dang & Kim SA. So far, I have found some very needed rest from the pre-exams tensions, in the course of my trip. Thank you for your most appreciated welcome in E. Lansing and I would enjoy hearing from you. Best wishes to you and my kindest regards to Dr. Austin and Dr. Hendry.

Dear Judy,

I am finally back to Cambridge and am preparing to meet my advisors at Harvard to discuss about my plan for writing the dissertation. I shall have to register for writing the dissertation in the Fall semester. It has been recently brought to my knowledge that I shall still have to register for a course in history in order to satisfy the "write-off" requirement in the field of history.

Please find enclosed the backs of the airplanes tickets used during my last trip. Upon receipt, I'd appreciate your sending me the re-imbursement for taxi fares; plus, if possible (since I was unable to get receipt for my expenditure for taxi -- the only means of communication between Detroit airport and Ann Arbor), the \$8.00 I had spent in connection with my visit with Ky. I hope you did enjoy your visit with him as I had expected. I also hope that Ky could come to Cambridge to do a bit of research here sometime next Fall.

I would be thankful if you could check if I was entitled to a raise of \$3.00 in travel per-diem (from \$12.00 to \$15.00) effective June 15, and if so, make any adjustment as necessary for me, as against the last travel per-diem check that I got before my departure from Michigan.

I am, otherwise, in the process of moving to a new address which is as follows:

At the same time, I am trying to gather some useful books (useful for Viet-Nam now, that is) for a first shipping to Viet-Nam, since my present load of books available to be sent back there, by far exceeds the shipping weight allowed by I.C.A..

Thanks for the July per-dieu check. Than do forward it to me while I was in New York City.

Although deferred, my trip back to Viet-Nam is still remembered as including some firm commitments to my friends here. Under present circumstances, I guess I shall have to work even harder than expected in my former plan, in order to achieve my mission as soon as possible. During my trip I had an opportunity to collect references at the Library of Congress and the Bunting Library on political studies, and had talked to helpful specialists in the field of Asian government and politics such as Prof. Lanevezer at John Hopkins, Prof. Bernard Fall at Howard University. I now expect to see Prof. Emerson on July 13 and, in two weeks (when he'll back from his vacation), Prof. Fairbank. I have also met Prof. Elliott who is very helpful and encouraging to be. - Please accept my best thanks and wishes! Sincerely, T. Phan





It was nice talking to you on the phone the other day. I think that Winter has finally hit this corner of the country. Old Man Winter has his charm any way. To tell you the truth, I miss the snow of East Lansing.



I thought that, perhaps, it will be somehow possible for me to get arrangement to go back there to see you at the Office for the Christmas vacation? And, maybe, on the way back from there I can stop by Washington D.C., to pay a visit of courtesy to the VN Ambassador? If this plan can work out, then I will be

planning to leave here for East Lansing (via New York, possibly?) early in the morning of Dec. 26, and arrive in E. Lansing sometime in the night and spend a couple of days there, and, then, fly back

to Boston, via Washington-D.C., on the 29th of Dec.. I feel that I must submit to you, along with this plan, the fact that my present American visa will expire on Dec. 29, 1961; and that, I shall have to get a decree from Viet-Nam, in order to renew it through the VN Embassy, and through the Immigration Office.

Also, I would like to report to the Project the fact that, in order to fix my ideas about my writing a thesis on Viet-Nam while in America (partial reason I have thought it useful to accept an offer from ITEK Corporation (in the communications business), to introduce some of their members to Viet-Nam and its language, who are scheduled to, eventually, go there on a professional exploratory trip. I did believe this would be among the wonderful works of international cooperation, which would substantially benefit the development of Viet-Nam. This corporation may eventually get a contract from the U.S. Government for its project. I am hoping that, perhaps, they will be able to get me ~~a~~ round ticket to and from Viet-Nam, for a visit to my long forgotten and neglected family, for a few weeks, and possibly by Tet time. And, then, I will be back early next year to continue my work for the thesis, to be able to finish it and undergo the "special exam." by April or June, depending on how quickly the development of my dissertation will proceed. Right now, the beginning of it is going steadily, but I am hopeful that it will get even greater speed as it embarks upon its course.

AS I EXPLAINED TO YOU ON THE TELEPHONE THE OTHER DAY, YOU HAVE ONLY \$15 LEFT IN YOUR TRAVEL ALLOWANCE. THUS, IT IS IMPOSSIBLE FOR ME TO ARRANGE TRANSPORTATION FOR YOU FOR ANY FIELD TRIPS AT THIS TIME. DEAN HENDRY MAY BE IN BOSTON AROUND DECEMBER 4 OR 5, AT WHICH TIME YOU MAY DISCUSS THE MATTER WITH HIM. THE ONLY SUGGESTION I CAN MAKE IS THAT WE WOULD STILL BE ABLE TO PAY YOU THE \$15 PER DIEM WHILE YOU ARE IN TRAVEL STATUS AND, IF YOU FEEL THIS WOULD PROVIDE YOU WITH ENOUGH FUNDS TO COVER COST OF TRANSPORTATION, ETC., I SEE NO REASON WHY YOU CANNOT PLAN TO VISIT WASHINGTON, D. C., IN THE NEAR FUTURE.

ENCLOSED HEREWITH IS A NEWLY FILLED-OUT DSP-66, WHICH YOU SHOULD FORWARD TO THE EMBASSY OF VIETNAM TOGETHER WITH YOUR PASSPORT FOR RENEWAL.

I THINK IT WOULD BE WONDERFUL IF THE POSSIBLE PLANS WITH ITEK WERE TO BE FINALIZED. OFFHAND, I CAN SEE NO REASON WHY YOU WOULD NOT BE ABLE TO FOLLOW THROUGH; HOWEVER, I CANNOT SAY AT THIS POINT JUST WHAT TECHNICALITIES WOULD BE INVOLVED IN OBTAINING APPROVAL FROM THE VARIOUS AGENCIES INVOLVED FOR YOU TO TAKE SUCH A "LEAVE" FROM YOUR WORK. THIS ALSO YOU SHOULD DISCUSS WITH DEAN HENDRY WHEN HE IS IN BOSTON.

Dear Judith:

I would like to thank you for having sent me the DSP66 and accompanying papers. I will forward it, together with my passport, to the VN Embassy. Please convey my sincere thanks to Mrs. E. Van Meter for her very precious advices concerning the procedure for extending my passport.

May I take this opportunity to express, once again, my deepest appreciation of your friendly comprehension and help in the past, especially during the difficult periods of transitions in my academic and research program. I called the Office yesterday and had a chance to learn, through Jo, that Dr. Hendry has not been back yet. Since I am writing this letter in the afternoon of today, and there is no news of his coming here yet, I presume that there has been some change in his travel plans.

I planned to make a trip to Washington, but finally decided not to, because of my fear that my travel allowance has run out for this year. If I do get a ride I will go there for one or two days, just the time necessary for carrying out administrative matters. But I might as well send my passport through the mail, and will not consequently need a trip for the moment. I do plan, however, to go to New Haven (Conn.) for one or two days sometime during this month to interview Prof. Paul Mus at Yale: If I can get an appointment

from him, I will let you know, and will request some cash advance for my travel perdiem to strengthen my purse. My advisor, Professor R. Emerson, has agreed to this plan. I will ring you some day about this. About the ITEK plan, since I have not yet got any new words from them, I assume that, perhaps, their contract has not been pushed through as of today. I think ICA will be able to do something about working out a procedure for a "leave," eventually, but I really cannot tell about what could be done in this connection. The plan seemed at first--and I am grateful that you so took it--attractive. But now, I guess I'd better concentrate on my academic and research work and get it done with. I found out, unfortunately not for the first time, that plans may not work out the way you would want them to or, at least, not as quickly as you would hope. Guess somewhere along the line--as you may be among the first persons to notice--I have become more philosophical and Wiser (yes, that's it!) and, thus, got adjusted to new circumstances and new times: But I feel happy about the whole thing, to tell you the truth. Things have changed for the better, as new developments are evolving themselves.

I feel much more at home now. The landlord (Mr. Ben Miele) has been quite good to me: We have even formed a "53 Trowbridge Club" whose activities include watching-TV and "a-cup-of-coffee" sessions, among other innocent friendly programs. Professor Emerson has helped me a lot, too, and not only academically. The people around are fine. They all call me "John"! Well, so long. Better stop here. Guess the fault lies with "poor" X-Mas mood (too bad I cannot make, it, West, this time).

Again, thank you for everything.
