Dear Dr. Hendry:

Being fully conscious of the gravity of the present hour in the history of Viet-Nam and the world, and realizing how deeply I am indebted to my Vietnamese and American friends and supporters, I am writing to you to express my gratitude to the American people through you, and especially to you and my personal friends present and past connected with Viet-Nam Project. I have come to the United States to learn more of the things which I could not learn in Viet-Nam, as well as to prove something which has always been important to me (and any youth probably) and my family: my maturity and manhood, which were obscured by my insecure living conditions in Viet-Nam. For this purpose, I have spent a lot of sid money coming from the American people, and benefitted from the sacrifices and support of my family and friends. Now, I think the moment has come when I have learned the minimum of what I have wanted to know, and proved to myself enough about myself. As you may be

among the most well-positioned persons to have noticed, the conditions in Viet-Nam have unfortunately degenerated from bad to worse security-wise. My family needs my presence and support now more than ever; and my friends in and out of the government may be missing me.

And yet, I have found myself in the present precarious and awkward situation academically and financially: Academically, I have not yet completed all my degree requirements; and the conditions in Viet-Nam are not very helpful in speeding up the process (despite my conscious inner efforts to do my everyday's duties to the best of my ability and capacity). Financially, I have run into debts (about five hundred dollars altogether). I hope to have your continued understanding for my efforts to keep myself up at the level favorable for my training program in this country.

I hope to be able to go back to Viet-Nam for a short visit to settle my personal problems at home at this time of crisis, under debt-free and security-guaranteed (insofar as possible) conditions. If you can find some way to help me out at the present juncture of my academic and professional program, I would be deeply grateful to you.

Trusting in you as more than a program manager, but, most truly as a friend if I may, I have submitted to you the above situation and request. Gratefully,

DEAR PHAT:

AS YOU HAVE UNDOUBTEDLY READ IN THE NEWSPAPERS OR HEARD FROM OTHER SOURCES, THE CONTRACT BETWEEN MICHIGAN STATE UNIVERSITY AND THE GOVERNMENT OF VIETNAM WILL END IN JUNE OF THIS YEAR AND WILL NOT BE EXTENDED. THE MICHIGAN STATE GROUP IN SAIGON HAS BEEN PLANNING SINCE MID-1961 TO TERMINATE THEIR TECHNICAL ASSISTANCE IN 1962, ALTHOUGH THERE WAS SOME DISCUSSION OF AN EXTENSION, AND THIS MATTER WAS SERIOUSLY TAKEN UNDER CONSIDERATION BY UNIVERSITY AUTHORITIES.

IN LIGHT OF DIFFERENCES OF OPINION WHICH AROSE BETWEEN THE GOVERNMENT OF VIETNAM AND THE UNIVERSITY CONCERNING THE ROLE OF THE LATTER'S ADVISORY GROUP, THE EXTENSION DID NOT APPEAR FEASIBLE NOR DESIRABLE. SINCE EVENTS LEADING TO THIS DECISION ARE "WATER OVER THE DAM" TO SOME EXTENT, THERE SEEMS LITTLE POINT IN PURSUING THE QUESTION OF WHERE THE RESPONSIBILITY RESTS. THE IMPORTANT THING FOR THE FUTURE IS THAT YOU CONTINUE YOUR WORK TOWARD THE DOCTORAL DEGREE AND COMPLETE IT AS RAPIDLY AS POSSIBLE SO THAT YOU MAY RETURN TO THE NIA TO TAKE UP YOUR DUTIES AS A PARTICIPATING MEMBER OF THAT INSTITUTION.

WHEN I WAS IN VIETNAM LAST FALL, I RECEIVED ASSURANCES FROM THE U.S. AID OFFICIALS OVER THERE THEY WOULD PROVIDE YOU WITH THE FINANCIAL SUPPORT NECESSARY TO COMPLETE THE WORK WHICH YOU HAVE BEGUN AS LONG AS YOUR PROGRESS CONTINUES SATISFACTORILY. I HAVE EVERY CONFIDENCE THEY WILL KEEP THEIR WORD AND THAT YOU MAY BE ASSURED YOUR WORK WILL NOT BE INTERRUPTED NOR SUMMARILY CURTAILED BECAUSE THE MSU PROJECT IS PHASING OUT. AS SOON AS I RECEIVE MORE DETAILED INFORMATION ON THE ARRANGEMENTS UNDER WHICH YOU WILL BE PROVIDED FOR, I SHALL WRITE YOU AGAIN. MEANWHILE, IF YOU HAVE ANY QUESTIONS, PLEASE DO NOT HESITATE TO WRITE, AND, I WILL ATTEMPT TO GIVE AS COMPLETE AN ANSWER AS POSSIBLE.

Dear Dr. Hendry:

I would like to thank you for your letter of February 23, in which you informed me of the present state of MSU contract with the VN Government and so kindly encouraged, once again, in my studies.

You have mentioned about the disagreements and differences of opinions concerning the MSUG's role in Viet-Nam. I think that this situation may be related to the overall difficult phase of transition of U.S. aid in Viet-Nam under present circumstances. Since at least 1958, I have heard so much unjustified, and at times not altogether well-meaning, criticism about this aid, that have passed from a state of permanent irritation, through deliberate ignorance of it, to a conscious, aggressive, attempt in trying to gather all these arguments and counter-arguments in order to critically examine them.

I have found that about nine-tenth or more of the samples, either provoked or unprovoked, never miss any occasion to confirm my original impression about them: i.e. THAT THEY ARE IRRESPONSIBLE PEOPLE. I do not want to speculate about their motives, but I have reason to suspect that they might not be very highly nor widely motivated as they seem to be in their criticisms. Sometimes they are the persons among the most privileged by U.S. aid, and yet ever ready to destroy or undermine it, with no thought whatsoever about their in consequence and harmful irresponsible attitudes. It would be disastrous if, because of those people, such challenging programs as MSUG will have to withdraw its precious shoulders from the tremendous

task of nation-building in Free Viet-Nam. I am worried at the vision of the morale effect of such a withdrawal, especially at the present juncture of events in Viet-Nam.

I myself have suffered from the criticism from the above category of people. Finally I have found out that they do not understand that there can be men who are both willing and able to work, in silence, with the difficult problems facing a Viet-Nam in crisis; or else, they do not understand all the aspects of the problems, and possibly, do not want to understand them. Then, recently I have found relative peace of mind by, once again, blacking out these tendentious noises from my mind and my heart, and concentrating even more on my everyday's duty.

The other kind of arguments over aid programs, however, gives much ground for hope and optimism for the objectives of MSUG and U.S. aid in Viet-Nam in general: This is a kind of what may be called clinical, constructive, or professional analysis of the operations and prospects of our aid programs. It tends to see various angles and connections of these programs, examine them against facts and data, and propose corrective solutions or alternatives among RESPONSIBLE and INFORMED audiences, forums and conferences. Although the search for a cooperative effort and a mutual understanding seems sometimes to be quite frustrating and ungrateful, but it is my feeling that it is going somewhere in the right direction. And of course we had anticipated frictions in our operations, in the field as well as on this side of the Pacific. As a participant, may I express the here-felt wish that MSUG will stay on duty, emerging as it is even stronger from the present crisis.

I know that my difficult case has added to your already heavy and balky burden. And I am sorry for it: Please forgive me.

Report from Tran Ngoc Phat
--for month ending February 28, 1962

So far, I have got my thesis started with its first part among the three scheduled parts. About the equivalent of an introductory chapter has been written, and under revision. I have found out that, in addition to the readings during the 1961 Summer, I have to read more in the background material about French Indochina. During the last semester, while taking a course in history (which I have passed with a satisfactory B, thus regularizing my status of freedom from course requirement for the Ph.D.) and trying out some writing, I have done about two thousand pages of reading in the French collection at Widener library, which covers mostly early history of what is now called Viet-Nam.

Now I continue to read as much as I can, but spend most of the working and waking time on the conception, writing and drafting of my thoughts for the dissertation. Although I had intended to visit my advisor regularly every week, I have not been able to get anything worth submitting to him for reading until every two or three weeks have passed, at each time. For my thesis, which is mostly in the field of study here called nationalism, I have more contacts with Prof. Emerson than Prof. Fainsod; although I hope to be able to maintain contacts with the latter now and later on when back in Viet-Nam, on problems of public administration--especially in administration for development.

It is my hope to be able to finish a proof-read manuscript of the thesis during the central part of this year, and hopefully by the end of June (the April date

has revealed to be somewhat unrealistic, in view of the additional renderings that have to be done).

Finally, I would like to acknowledge the reception of my February per-diem check. I appreciated its early expedition, which was very helpful for the "Tet" ... follies.

DEAR PHAT:

WORD HAS NOW COME FROM SAIGON AFFIRMING THAT THE UNITED STATES GOVERNMENT, THROUGH USAID IN SAIGON AND AID IN WASHINGTON, WILL CONTINUE SPONSORSHIP OF PARTICIPANTS WHO HAVE NOT COMPLETED THEIR PLANNED COURSES OF STUDY BY JUNE 30, 1962, WHEN THE MICHIGAN STATE UNIVERSITY CONTRACT TERMINATES. THIS SHOULD HELP REMOVE SOME OF THE DOUBTS WHICH I AM SURE HAVE ARisen IN YOUR MIND AS THE RESULT OF THE CONTRACT TERMINATION. I STILL DO NOT HAVE DETAILS ON WHERE PARTICIPANTS ARE TO REPORT OR HOW THE ACADEMIC, TRAVEL AND PER DIEM EXPENSES WILL BE ADMINISTERED AFTER JUNE 30. AS SOON AS THIS INFORMATION BECOMES AVAILABLE, I WILL INFORM YOU IMMEDIATELY.

THE MAIL FROM SAIGON CONTAINED AN EXCERPT FROM THE USAID OFFICE THERE CONCERNING PROCEDURES TO BE FOLLOWED IN THE FUTURE FOR EXTENSION OF EXISTING ARRETES. A COPY OF THIS EXCERPT IS INCLUDED FOR YOUR INFORMATION. IN THE PAST WE HAVE LEFT THE RESPONSIBILITY FOR INITIATING ACTION FOR ARRETE AND VISA RENEWAL largely UP TO YOU, BUT IN THE LIGHT OF THE TRANSFER OF ADMINISTRATION OF YOUR SCHOLARSHIP FROM MICHIGAN STATE UNIVERSITY TO AID, I WOULD LIKE TO MAKE CERTAIN THAT EVERYTHING IS IN PROPER ORDER WELL IN ADVANCE OF THE CHANGE-OVER. IN REQUESTING AN EXTENSION OF THE ARRETE, I THINK IT WOULD STILL BE WISE TO SUBMIT A LETTER TO THE RECTOR OF THE NATIONAL INSTITUTE OF ADMINISTRATION, BUT AS THE ENCLOSED EXCERPT INDICATES, IT WILL ALSO BE NECESSARY TO OBTAIN CLEARANCE FROM THE DIRECTORATE GENERAL OF PLAN. REQUESTS FOR THIS LATTER CLEARANCE SHOULD BE FORWARDED THROUGH THE VIETNAMESE EMBASSY IN WASHINGTON.

SINCE YOUR ARRETE IS DUE TO EXPIRE IN MAY OF THIS YEAR, AND SINCE YOU ARE NOT CERTAIN WHETHER OR NOT YOUR WORK WILL BE COMPLETED BY THAT TIME, I SUGGEST THAT YOU MAKE APPLICATION FOR AN EXTENSION OF YOUR ARRETE TO THE RECTOR OF THE NATIONAL INSTITUTE OF ADMINISTRATION AND TO THE DIRECTORATE GENERAL OF PLAN AT THE EARLIEST OPPORTUNITY. PLEASE LET ME KNOW THE DATES ON WHICH YOU FORWARD SUCH APPLICATIONS. I ALSO FIND THAT OUR RECORDS DO NOT INDICATE THE EXPIRATION DATE OF YOUR PASSPORT AND THE EXPIRATION DATE ON YOUR U.S. VISA. PLEASE LET ME KNOW THESE DATES AND ALSO NOTIFY ME OF THE DATES WHEN YOU SUBMIT ANY APPLICATION FOR RENEWAL OF YOUR PASSPORT AND



As I got to know more and more places and peoples, I have learned to love each new community I passed by. No longer are deep-rooted simplistic images of the world around me, tenable. Thus, I have learned to love the noses of Hongkong, Tokyo, Honolulu, San Francisco, East Lansing, Cambridge, Boston, etc.... Each place has given me new meanings and inspirations about life and humanity. In each new person and each new community, I have found a reflection of my own reality, problems and aspirations as well as the universality of the greatness and misery of the human condition on earth. To be true, I think that my personality has been immensely enlarged and deepened with these new contacts.

Let me say that I do share with you your admiration for the internal and external beauty of cities, beyond their everyday's problems. May your heart's desires, in this connection, be fully realized.

I have to close this letter at this point, while waiting for the next opportunity of communicating with you. Please accept my most sincere thanks for your speedy processing of my per-dieu and refund checks.

P.S. - I have not been able to make any new living arrangements as yet. I will think of it at a more relaxed time. If there is any change in living accommodations, I will let you know.
