DATE: May 16, 1961

Shortly after, or just before, the return of Miss Kim Sa to the NIA library, we hope to send Miss Ti, the head librarian, to a University in the United States for her Master's degree in library science. Miss Kim Sa is expected to return to Saigon in June, 1962.

From our various reports you are undoubtedly familiar with the problems we face regarding Miss Ti. The Fonction Publique gives little credit to her Philippine Degree, and as a result, she has been relegated to a low civil service status with a salary equal to only one half of some of the clerks (paid by MSUG) who work under her. We are definitely going to lose Miss Ti if something cannot be done to give her the position, status, and salary she deserves. Unquestionably, she is the most competent librarian in Vietnam, and in our opinion, would be a valuable asset to any library; besides knowing library work, she is a dynamic, capable administrator and possesses an abundance of common sense. She had an outstanding academic record at the University of the Philippines, where she obtained her BA with a major in library science. Both Dr. Child, who served as library advisor, and Miss Heyman have praised her in superlative terms.

Since the possession of degrees - and not necessarily one's competency - means everything in VN, the best solution in her case is to permit her to get her MA degree from a quality US University; this would result not only in bringing her into the Tham Su class and giving her a reasonably adequate salary (thus raising her the equivalent rank and salary of Miss Kim Sa who will work under her supervision) but also in enhancing her competency and her value to the NIA.

Therefore, may I please make a request for some information which we would find difficult to obtain here. Will you kindly

ascertain from someone in the MSU library: (1) the names of at least 10 or 12 universities from which she might obtain first rate training and receive a MA in library science within one year; (2) whether the universities named are on the semester or quarter-term system. The second item of information is asked because it may be possible for Miss Ti to begin her studies in March 1962, although it is more likely that she would start in summer session of 1962.

Dear Ruben:

We are very pleased to assist you in finding a library school for Miss Tang Thi Ti. She was at the Institute when I was in Saigon, and I can assure you that she would make a wonderful candidate for a library school here in our country.

I am not in a position to evaluate Miss Ti's record. I cannot, therefore, tell you if she could finish her degree in one year. This will have to be done by the library schools.

The following library schools can be recommended. Those with a star are on the quarter basis, and the others are on the semesters.

1. University of Illinois
2. University of California (Berkeley)
- *3. Chicago University
4. University of Michigan
5. Columbia University
6. Rutgers University
7. Indiana University
8. Florida State University
9. Louisiana State University
10. Rosary College (Chicago)

All of these are good schools and can be highly recommended.

I sincerely hope that she manages to come to the United States for further training. I am sure that she would benefit from it and I am sure that the Institute would benefit from her additional work.



Miss Ti will not go to the US before June and prefers to wait until September. She is now engaged to be married and expects the wedding to take place about April. At first she said she would not consider going to the States before September, but when I pointed out our contract ends in June and she might have to leave before that time if she is to go under MSU auspices, she said she would go in June rather than forego her study. However, in the event our contract is renewed or if USOM will accept her, she wants to wait until next fall.

Incidentally, Thong has never met with the Budget Direction to have the library assistants paid from counterpart funds, though I have taken the matter up with him at our every Thursday meeting, and in several memos. Although he has never really said he opposes the arrangement or that he will not seek it, he has expressed the fear that he might lose the library assistants if he takes them out of the regular budget. I have said repeatedly I believe it would be possible to make an agreement with the Budget Direction that the library assistant positions would be returned to the NIA after a year, and have offered to call a meeting for that purpose, but he has not responded favorably. I will keep plugging.



She is a pagan and he is a Catholic. He wants her to become a Catholic and, although she tentatively agreed to do so at one time, she is beginning to have second thoughts on the matter.
