CONGRATULATIONS ON THE PROGRESS YOU ARE MAKING TOWARD YOUR DISSERTATION. WE SHALL BE VERY HAPPY TO HELP YOU IN PROGRAMMING YOUR RESEARCH. AS YOU SHOULD BE AWARE, TO QUALIFY FOR THE PER DIEM OF \$12, YOUR RESIDENCY OUTSIDE OF NEW YORK CANNOT EXCEED 20 DAYS IN ONE PLACE.

BY NOW, YOU SHOULD HAVE RECEIVED OUR NOTICE CONCERNING BOOK ALLOWANCES. ACCORDING TO CURRENT ICA REGULATIONS, WE CANNOT ADVANCE MONEY FOR BOOKS, BUT CAN REIMBURSE YOU FOR PURCHASES MADE DURING THE ACADEMIC YEAR. I HOPE THIS WILL NOT BE TOO GREAT AN INCONVENIENCE--PERHAPS YOU WOULD BE ABLE TO CHARGE THE BOOKS IN YOUR OWN NAME, OBTAIN A BIL FOR THEM, AND THEN WE SHALL PROCESS REIMBURSEMENT.

AS OF NOVEMBER, 1960, PER DIEM WILL BE PAID ONE FULL MONTH IN ADVANCE. ENCLOSED IS YOUR CHECK FOR \$240 COVERING THE PERIOD NOVEMBER 1-30, 1960.

THE ADDITIONAL \$4 PER DAY, PAID WHILE A PARTICIPANT IS IN "TRAVEL STATUS," WILL BE PAID TO YOU SEPARATELY AND NOT COMBINED WITH THE REGULAR \$8 PER DAY SUBSISTENCE CHECKS. ALSO, PLEASE BE ADVISED THAT THE EXTRA PER DIEM, LIMOUSINE AND TAXI FARES IN CONNECTION WITH OFF-CAMPUS TRAVEL CANNOT BE PAID UNTIL THE CANCELED RECEIPTS AND/OR TICKET STUBS ARE RECEIVED IN THIS OFFICE. IN OTHER WORDS, THE ADDITIONAL PER DIEM AND TRANSPORTATION CHARGES CANNOT BE REIMBURSED TO YOU UNTIL AFTER SUCH A TRIP IS MADE. IF, HOWEVER, TRAVEL ARRANGEMENTS ARE MADE THROUGH THIS OFFICE, WE SHALL PURCHASE AIR OR TRAIN TICKETS IN ADVANCE OF YOUR TRIP AND FORWARD SAME TO YOU.

ONE MORE ITEM IS THE MATTER OF REPORTING. ATTACHED IS A SAMPLE REPORT WHICH WE WOULD LIKE FOR YOU TO FOLLOW AS CLOSELY AS POSSIBLE. WE REALIZE SOME OF THE PARTICIPANTS HAVE COMPLETED THEIR COURSE WORK, IN WHICH CASES A GENERAL REPORT OF YOUR ACTIVITIES IS IN ORDER. WE LOOK FORWARD TO RECEIVING THESE REPORTS EVERY THREE MONTHS, THE FIRST ONE BEING DUE DECEMBER 31, 1960. ANY FIELD TRIPS TAKEN SHOULD BE WRITTEN UP AS A SEPARATE REPORT IN PARAGRAPH FORM AS SOON AFTER A TRIP IS TAKEN AS IS PRACTICABLE.
