BIOGRAPHICAL DATA

Mr. Horacio S. Borromeo
Community Development - Philippines

Mr. Borromeo, age 50, is a Regional Supervisor over community development teams in four provinces on the island of Mindanao. His duties consist of checking and evaluating reports of field activities, co-ordinating the services of health, public works, education, agriculture and social welfare in community development projects. He assists in the organization of provincial and municipal development councils and works closely with the provincial governors and municipal mayors in the implementation of the community development program. The main problem in this area is the coordination and smooth functioning of the technical services, the stimulation of self-help activities and maintenance of enthusiasm and high morale among isolated workers.

During the ten weeks that Mr. Borromeo has been in the United States he has had an opportunity to observe community organization and adult education work of the "College in the Country" program at West Georgia College, study in depth training and supervision of barrio level workers and the organization and operation of the Division of Community Education in Puerto Rico, observe the integrated approach of the Jamaica Social Welfare Commission in its community development program, participate in meetings and seminars for a Ford Foundation sponsored group in community development at Cornell and to study the program of the Bureau of Community Development at the University of Wisconsin.

In carrying out his duties, Mr. Borromeo needs training and experience in democratic supervision, administration of technical services, group formation and group action. His specific objective while here in Michigan will be an across-the board look at supervisory techniques.

Mr. Borromeo holds a law degree from the University of San Carlos.
