
Dear Mr. Dorsey:

Mr. Duong Vinh Mau is finishing his stay with us today and we are happy to report that we have enjoyed his visit with us very much. We hope that during the past three weeks that Mr. Mau has benefited by his observations in our laboratory.

In addition to studying our laboratory methods for the recovery and estimation of insect and rodent filth, decomposition of fish and shrimp, and assay of drug products, Mr. Mau had the opportunity to go with one of our inspectors while making a factory inspection. He has also visited the Customs laboratories and went on a tour of a sugar refinery accompanied by Customs personnel.

Thank you for your letter of March 4 in regard to Mr. Duong Vinh Mau, a Vietnamese official studying in this country. We appreciate your kind offer to have Mr. Mau work with your laboratory in the latter part of May. Mr. Stephens of your Washington office has raised the same questions that you mentioned in regard to the values of Mr. Mau's study of Food and Drug operations rather than Customs.

While Mr. Mau is in the Customs Service in his own country, his laboratory does work similar to yours. However, Mr. Mau will visit with Mr. Stephens in the Washington office and discuss the most profitable type of training with him. A definite assignment of Mr. Mau's time should wait for the result of that conference.
