- April 18 Conference with Robert Walter, Principal Personnel Examiner, Administration Division, Detroit Civil Service Commission.
- April 19 Interview with Warren D. Wilt, Safety Coordinator, Detroit Civil Service Commission.
- April 22 Conference with Grovenor Grimes, Personnel Officer, Department of Health.
- April 23 Head Hospital Nurse training session at Receiving Hospital.
- April 24 Visit to Ford Motor Co., Rotunda, Rouge Plant and Greenfield Village.
