Dear Miss Cunningham:

Mr. Rafsky has asked me to reply to your letter of April 24, concerning the possibility of Mr. Nguyen Van Dai's visiting Philadelphia to observe the urban renewal program and city government operations in general.

The Council for International Visitors is the agency which usually arranges such visits to Philadelphia, and I have talked with Miss Laws of the Council concerning Mr. Dai. Because it is difficult to tell in advance just what facets of city government Mr. Dai is interested in, and what type of "observation" he desires, Miss Laws suggests that he come directly to her office on Monday, May 6 to talk with her first before she works out any specific program for him. She will then be able to arrange something in line with his own wishes on the matter. This Office will, of course, assist in working out the urban renewal parts of his program at that time.

I am sending your letter on to Miss Laws, and, if you have any further information as to the time of Mr. Dai's arrival or more specific data as to his interests, you should write to her direct.
