Subject: Chanh

Ralph Turner and I are both concerned with the anticipated problem of Mr. Chanh's desire to return home in less than five months. We are both convinced that the anxiety in his mind is such that his performance will be affected. You probably know of his concerns. They revolve about his own operations in Saigon, and I suspect reflect a situation of a man being too emotionally involved in his own work. (I am not sure I object to that sort of thing.) He is anxious to stay in East Lansing only three months while working extremely intensively and to preclude travel to Washington, New York, etc. Ralph feels that a meaningful, well-packed program can be arranged for him, including short field trips in and out of Lansing.

Chanh claims that he spoke with Lam Le Trinh the day before his departure and that Trinh promised to support his request for a shorter tour here. In checking this out be careful of the implications of his having gone around General La. See if the shorter tour can be arranged. There is no point in forcing a person to stay when he is so disturbed that his anxiety interferes with the benefits to be derived. On the other hand, we are concerned that his insistence on returning early may actually jeopardize his relations with General La and the Government. That you will have to evaluate. Ralph feels that Chanh can be a key figure for Ralph's own activities in Saigon, and we want to make certain that Chanh doesn't undermine his own role by all this.

Please find enclosed several copies of the on campus briefing finally arranged for the police leaders. I am also including copies of their current expectations for the remainder of the program.

Outside of the fact that Mr. Huong thinks he ought to attend the FBI School and a general desire to spend more time in Washington and less in St. Louis - everything seems pretty much under control. Major Phong has presented us with a letter written by Mr. Ho of the Olympic establishment in Saigon to Mercury Motors in Milwaukee, and I am presently trying to arrange that he and Mr. Shelby spend Friday at the plant.

I trust that Chanh will be able to make out with the assistance of the Vietnamese participants currently on campus. Today they had a few moments with Capt. Ngoc and Lt. Thanh who were evidently passing through Lansing on one of their two-day stop-overs. My impression was that their whole program has consisted of floating from police department to police department. This is the reason why we have so many difficulties explaining to our police participants the limited value of such a "cook's tour" -- a very pleasant way to see the country but not particularly useful from the standpoint of really digging into the work.
