The following is a copy of the report from Gilbert Shelby from St. Louis, Missouri:

"Every one is doing fine and are happy. Mr. Houn is working primarily on the lie detector; Bay and Ve more on general coverage. Mrs. Neelly is with the latter two. Major Phong and Miss Levy are in Jefferson City. They have received a sincere welcome there and the Major will learn a great many things, I am sure.

All arrangements have been made for their return here. We were able to visit a large army camp on the way to Jefferson City, (Camp Leonard Wood.) without delay or extra expense.

The men have decided they want to stay at the Y.M.C.A. in Washington. I think you had better make the reservations there or where you see fit. Houn stated that a former visitor had stopped at the Harrington Hotel which he found good and cheaper than the R. Smith. If you don't find space available at the Y. you might try there, if you like. I would rather not stay at the Y.M.C.A. but will be satisfied at any hotel in the area where the others are staying. We will leave it in your hands and promise not to complain.

I don't believe it is necessary to take both interpreters to New York. If a man from the C.I.A. goes with us to N.Y. it will not be necessary to take either. Has the die been cast on this or should I decided when we are ready to go? If I have a choice it will be Miss Levy. Mrs. Neelly is not working out so well, but I will explain when I return to E. Lansing.

May we ship books or material or small articles to you at E. Lansing for shipment to our offices in Saigon? Are these articles limited and to what extent? Phong shipped outboard motor parts to you for relay to Saigon. Reasons: no duty in Vietnam if to MSU Office; please indicate your attitude toward this practice.

Don't worry about this group - everyone is well, in good spirits and all are enjoying their visits; They are learning a great deal. Did anyone send flowers to Houn's son's funeral? If not, we can have a few masses said in Saigon at \$1. each. Fini. As ever, G. Shelby"
