Dear Mr. Thurston:

Thank you for your letter of June 1 concerning Mr. Chanh. As a matter of fact Mr. Sheinbaum had just discussed with Mr. Theo Hall arrangements for Mr. Chanh's visit to Washington on June 15-17.

Mr. Chanh will be arriving in Washington on June 13 on Capital 104 at 5:02 p.m. He will be accompanied by Mr. La Van Hung, a participant from his laboratory who has been studying at MSU since last September.

Mr. Chanh will depart from New York for London on June 21. The time of his departure on the 17th for New York has not been set. Both he and Mr. Hung will go to New York via Greyhound Bus.

In addition to his work at the police laboratory on campus, Mr. Chanh has visited the police laboratories in Chicago, Madison and Cleveland with a member of the police administration school faculty. At the State Laboratory he spent three days observing the work done there.

Dear Mrs. Neelly:

This morning we received your check for salary, no. 281220, returned with letter saying that the salary payment period should have included the 16th through the 19th in addition to the days covered by the salary check. Elsie was able to get in touch with Mr. Shelby to verify that our understanding was correct, and we have issued another payroll card to cover the additional four days. We are, therefore, returning this check for your use. The four days' salary will be covered in the check issued at the next regular pay period, Friday, June 12, and we will forward it to you.

In reference to the beginning date of your employment, we refer you to our letter of May 5, 1959, in which we stated that salary was being computed on a Sunday-through-Saturday basis and therefore your first check did cover the period beginning April 5, although this is a bit at variance with the "pay ended" date as stamped in the upper left hand corner of your statement of earnings with each check. If you will add up the number of days covered in the "time" box of your statement of earnings for the checks you have received, these should equal the actual number of days you were serving as interpreter with our project, from April 5 through May 19, inclusive. According to our count, this should be 45 days, and a total of \$900 gross earnings.

SUBJECT: Lost PAA Ticket

PAA/Saigon would have to ask us to deposit local currency for the reissued ticket for Nguyen Cong Chanh since there is a chance that the lost ticket will be used. If we are to make such a deposit, we must get authorization from the Government of Vietnam since we purchase tickets at the 35 to 1 rate of exchange. I would prefer not to do this if you can deposit dollars instead in East Lansing. Since Mr. Chanh will not be coming back until after June 30, any additional travel costs for participants would be picked up at that date under the dollar contract anyway, and your use of funds for this purpose could, therefore, be considered legitimate.

If, for some reason, this cannot be done with dollars let me know, and we will ask the GVN to authorize such a deposit. If we do, it may be very hard on Mr. Chanh.

SUBJECT: Lost PAA Ticket (#205 - Ref: Your memo of 6/10)

Before giving Mr. Chanh the PAA ticket from here to Saigon, Mr. Miller requested him to sign a release. As I understand it, this release means that he would be responsible if the ticket turns up within the three month's period. However, the M.S.U. address is on this release, and we would, of course, pay this.

As for how the ticket was lost, this still is an unsolved problem. My recollection is that Mr. Chanh's ticket was given to College Travel along with those of the other police leaders. Mr. Chanh states that he turned over these tickets to Huong who subsequently gave me all of the tickets for reissue while the police leaders were in East Lansing. However, I was in the College Travel office recently when a thorough search was made for these tickets.

I do not expect that these tickets are actually lost in the sense that someone else can use them for transportation, but I know that Pan American must protect themselves in a case like this.

Dear Mr. Thanh:

On June 23rd Mr. Nguyen Cong Chanh will be returning to New York for an additional ten days prior to his departure for London and Saigon. On his earlier visit to New York Mr. Chanh was accompanied by another participant who has been in the United States since last September. However, on his second visit, Mr. Chanh will be in New York City unaccompanied. He does not speak English very well and I feel that it might be helpful if he had an opportunity to meet some of the Vietnamese who live in New York.

Mr. Chanh is head of the police laboratory in Saigon and arrived in this country at the same time as Messrs. Huong, Ve, Bay and Phong. During most of his stay he has been in the laboratory of the police administration school here. In addition, he has visited Chicago, Cleveland, Madison and Washington, D.C.

If you have the opportunity to meet Mr. Chanh I would certainly appreciate anything you might be able to do for him. He will be staying at the Woodstock Hotel.

Mr. Chanh was apprised of the fact that he had a three month's extension for his stay in the United States before his departure from campus for Washington and New York. However, frankly speaking, I do not believe that he was able to grasp sufficiently the information presented to him to warrant his remaining on the M.S.U. campus longer. His lack of English constituted a real barrier.

At all stages we consulted Mr. Chanh on his wishes for the program arrangements. I am definitely of the opinion that any traveling or moving about would require an interpreter. We were able to bridge this problem very nicely at this time but only by availing ourselves of the time between terms were we able to take the opportunity to have Hung accompany him on these trips.
