Dear Sir:

Professor Dorsey of our Saigon office has asked us to forward directly to you a notarized copy of the per diem amounts the ten Vietnamese participants at Michigan State University have received since their arrival here. I am also arranging to send to you the amounts each of them receives every month.

As we understand it the Government of Vietnam Embassy is to arrange for a differential payment to the participants for the support of their families. The differential payments refer, we believe, to the difference between the amounts of their regular governmental salaries and the per diem they receive from Michigan State University.

I presume to urge the utmost haste in this matter. I am enclosing a copy of a letter from one of the participants, Mr. Nguyen Dien, to the Ministry of Finance. This should indicate the concern that the participants are beginning to show. They are considerably worried over the well-being of their families in Vietnam. I am concerned for their families, and I am concerned that their work here at Michigan State should not be hindered because of their worries for their families. Could you please inform me as soon as you are able as to what steps it has been possible for you to take in this matter?


Dear Mr. Sheinbaum,
