This course has a large (60) enrollment and therefore there is little class participation by the students. I ^{have} no way to judge this factor in the behavior of these persons. So far as written work, including quizzes and tests, I can say that they have done very well. I have made allowance, however, for their English deficiency. On various occasions they have consulted with me about the problems of their country and have shown an active interest in the material covered in the course. These students have made a better impression than those with whom I came in contact last year. They are, I think, less sophisticated and thus more willing to learn.


